ORDER

The fee for examination and other services rendered by Pareeksha Bhavan was fixed vide University Orders read (1) to (8) above.

As per paper read (9) above, sanction has been accorded for enhancement in the existing fees / charges for the various services rendered by the University by 5% with effect from 01.06.2024 and directions have been issued to all the Heads of Teaching Departments/ Branches / University Centres, to issue necessary orders in this regard. Enhancement will be 5% increase in the existing rate and if the increased rate is not a multiple of Rs.5/-, the revised fee / charge will be fixed to the next highest multiple of Rs.5/-.

Accordingly, sanction has been accorded by the Vice Chancellor to enhance the existing fees / charges for examination and other services rendered by Pareeksha Bhavan by 5%, with effect from 01.06.2024.

The fees / charges for examination and other services rendered by Pareeksha Bhavan is, therefore, enhanced by 5% with effect from 01.06.2024, as stipulated in the University Order read (9) above. (The revised fee structure is appended).
